3392. Chairman's Allowance – request from Finance Committee To set up a Task & Finish Group to discuss

The Chair of the Finance Committee explained that it had been agreed at the last Finance meeting to keep the allowance the same at £1,750 and the Finance Committee were proposing a Task & Finish Group be set up to agree the amount going forward, what accounting records were needed and who can access it, the Chairman and the Vice Chairman?
